

April Luncheon Speaker:

Our speaker for the April meeting will be Congressman Mike Conaway. Recently sworn in for his fifth term in the U.S. House of Representatives, Congressman Mike Conaway represents 29 counties in Central and West Texas. Mike's background as a CPA motivates him to push for fiscal responsibility in Washington, including reducing the federal debt. He has sponsored legislation to create a simpler and fairer tax system, increase accountability in government funding, and protect small businesses and family farms from tax increases.

Mike is the chairman of the House Ethics Committee, a deputy Republican whip, and a member of the House Agriculture, Armed Services, and Intelligence committees. On the Agriculture Committee, Mike serves as the chairman of the Subcommittee on General Farm Commodities and Risk Management, working to protect the interests of rural America and its farmers.

A native Texan, Mike grew up in Odessa and graduated from Odessa Permian High School and Texas A&M University-Commerce.

A Midland resident and an ordained deacon in the Baptist church, Mike and his wife Suzanne have four children and seven grandchildren.

He will be speaking on the political environment and current trends in the oil and gas industry.
